

# IALA Level 1.1 Marine Aids to Navigation Manager Training

Course Programme 2024-25

#### **Course Overview**

Training in all aspects of Marine Aids to Navigation (AtoN) from planning, risk assessment, provision and maintenance is essential for reliable AtoN delivery to promote safe navigation and compliance with International obligations. The successful delivery of AtoN services depends upon competent and experienced personnel to implement and maintain these services.

This course is developed and maintained by the International Association of Marine Aids to Navigation and Lighthouse Authorities (IALA) to support their strategic goals by promoting training and sharing expertise.

Trinity House, in its capacity as an IALA Approved Training Organisation is running the Level 1.1 AtoN Manager course from September 2024 to March 2025.

The course will be delivered in compliance with IALA Recommendation R0141 and IALA Model Course L1.1 with experienced and qualified AtoN managers and engineers.

## **Course Structure**

The course consists of three modules:

## Module 1 covering:

- An introduction to IALA and other international organisations concerned with maritime matters and safety of navigation
- Introduction to the marine environment and marine aids to navigation
- · Basic nautical knowledge
- Introduction to AtoN
- · The view from the bridge

#### Module 2 covering:

 Technical functions of short range visual and audible AtoN



- Technical aspects and functions of satellite and terrestrial radio AtoN
- · Automatic Identification Systems
- Remote monitoring
- e-navigation
- The principles of Vessel Traffic Services
- AtoN structures, their materials and the conservation of historic Lighthouses
- Power supply systems

#### Module 3

Module 3 is a one week residential course in Harwich, England and includes topics on:

- The role of the Competent Authority and their international obligations
- Planning and publication of Levels of Service statement
- · Contractual procedures and funding models
- Environmental responsibility and the protection of the marine environment
- · Marine AtoN Management
- A final group major planning exercise requiring participants to act as the National Competent Authority of a small coastal state charged with the delivery of an internationally compliant AtoN service



Tutorials will be held either face to face or by telephone conference during modules 1 and 2 with online support.

Full details of the course syllabus are in IALA Model course L1.1.

The course will be delivered in the English language.

# **Entry Requirements**

Potential participants will be required to undertake a pre-course assessment to ascertain whether the minimum requirements for participation in online learning are met. The assessment is designed to review functional skills such as English and mathematics in addition to basic marine knowledge.

Candidates must ensure that they are able to allocate time to study by distance learning.

#### **Assessment**

To achieve the Level 1.1 Marine Aids to Navigation Manager qualification, candidates will be required to successfully complete a range of assessment activities. These include a written examination for each module and practical tasks during the residential Module 3 course.

To be awarded the IALA Level 1.1 Marine Aid to Navigation Manager qualification, candidates are required to achieve a minimum score of 50% in all assessment activities.

#### **Course Materials**

All course materials will be provided by Trinity House.

Good access to the Internet is required to access the on line learning portal and a valid email address.

Candidates will require a laptop/tablet to access the internet for Module 3.
