## PURPOSE OF JOB

To work as part of the Deck Department onboard TH Tenders, supporting the Petty Officers in all Deck related operations. TH Vessels work under Inter Departmental Flexibility and as such suitably trained Seafarer may be required to work in other Departments onboard.

#### MAIN ACTIVITIES AND RESPONSIBILITIES

#### 1. Shipboard Maintenance

- In consultation with the Bosun, carry the maintenance tasks for the duty period as directed;
- Responsible as delegated by the Bosun for the husbandry of the ships boats.

#### 2. Service Operations

- Carry out foredeck work to include all aspects of buoy and light vessel maintenance;
- Work with lifting equipment such as the effective slinging of superstructures, top marks and solar equipment;
- A good understanding of paintwork systems, including the safe use and application of;
- Operate deck machinery (when internally qualified);
- The use and care of rope and slings;
- To form part of the flight deck crew during helicopter operations;
- To form part of the Bridge Team with regard to steering and lookout duties, when required to do so.

#### 3. Stores

• Assist the Bosun in maintaining working stores levels to ensure adequate materials are available to carry out shipboard maintenance.

## 4. Health and Safety

- A good understanding and awareness of the safe use of machinery and hazardous substances, with particular reference to COSHH, Work Permits, H&S Notices and Documentation.
- Adhere to stated policies and procedures relating to health, safety, and environmental and quality management.

- Ability to work flexibly with other members of the ship's crew;
- Ability to support the Bosun in the effective maintenance of the ship and navigation aids.
